I just finished "Licensed To Lie" by Sidney Powell, attorney for Jim Brown in an indictment against him by our government. This may be a self-published book (I see no imprint). Sydney Powell is an attorney (formally working for the DOJ) and was involved in the appeal of a Merrill Lynch defendant. This is a good expose of what is wrong with the DOJ (almost all the convictions in the Enron trials were overturned. In addition, Arthur Anderson went bankrupt.

Some of the prosecuters on the ETF went on to higher positions (seems no one who works for the government in non-elected office pays a price). This include Andrew Weissmann (Mueller's pit bull). The mission of the DOJ of justice should be "justice", not "winning at all costs".
