Wow! Definitely a wild ride and a great mystery. This book focused on Amanda Jaffe, a criminal defense attorney, who works for her father, Frank. We are brought into the world of criminal defense attorneys...never a dull moment defending people who you hope are innocent, but bring you into a world of danger. The book starts with the black market of selling organs, specifically a heart. This deal, though, has gone wrong when police raid the drop off. Dr. Clifford Grant speeds away with the heart still in the trunk, but when he gets home to his "partner doctor" in this whole thing, he is killed.

We are then "introduced" to the doctors and staff at the hospital. Dr. Vincent Cardoni is obviously on drugs, and is yelling at a nurse, Mary, for a mistake caused by him. Dr. Justine Castle is separated from Cardoni and is seeing another resident, Dr. Tony Fiori. Dr. Carleton Swindell is the hospital administrator who has to handle all the paperwork from his staff either being killed or arrested.

So the first arrest made is Cardoni. The nurse who he was yelling at in the hospital is found not only dead, but tortured in a secluded house. More bodies are also found. Cardoni thinks he is being set up by his wife, Justine. She testifies against him in court. Bobby Vasquez, a vice cop, also testified against him, but Frank Jaffe, defending Cardoni, finds out Vasquez lied in court to cover up his illegal entry into the house where the nurse was found. So the case is thrown out and Cardoni is set free.

In the meantime, Amanda finds a severed hand that belongs to Cardoni, but a body is never found. She is interested in Tony Fiori but when she goes to his house seeking comfort after finding the hand he's with Justine Castle.

Four years later, a hospital custodian, Andrew Volkov, steals a mug from an office (Justine Castle's) and soon an anonymous 911 call to the police leads them to Justine escaping from another abandoned house. She had come to the home because of an emergency call saying someone needed help, but it was too late, a body was found, dead. But Justine's mug and surgical cap are found at the crime scene so she is arrested. Amanda defends her with help from her dad. For a while, it also seems Justine has been set up.

Amanda also rekindles her budding romance with Tony Fiori, who says Justine was just a fling.

Vasquez is hired by Amanda to help her with the case and try to catch Cardoni, who everyone thinks is the murderer.

Eventually Justine is considered free to leave prison. Cardoni was actually Andrew Volkov, the custodian, having had plastic surgery to get a new hand and appearance. There is no evidence out there that can convict Cardoni, and he still swears he is being set up.

Vasquez ends up in the hospital, being shot while following Cardoni to a public rest stop. Cardoni is also found, saying he had been tranquilized. And he was, after his blood was checked...but who did that?

Amanda, staying with Tony, gets a phone call from Justine saying to come to her right away because she's in trouble. She goes with Tony since she doesn't feel safe going alone. When they get to Justine's house, Tony tells her to wait in the car, but she follows him, hearing two gunshots. She finds Tony shot Cardoni. Justine, tied to a chair, looks like she's been tortured, and killed.

After talking to her father about his fellow law partner who happened to be Tony's father who was killed, Amanda realizes who the killer has been...none other than Tony! Amanda talks to Mike Greene, district attorney, and they plan along with other law enforcement, to take Tony down. Amanda goes to Tony's house supposedly for dinner, but talks to him hypothetically about how he could have been the killer. Tony catches on and tries to escape with her and eventually torture her too, but thankfully, the SWAT team and Cardoni, who followed her to Tony's house, stop him. Actually, Amanda gets taken to a hospital to get checked out and Cardoni is the one to find Tony. He does the best revenge to the guy and lets Martin Breach, big time drug dealer, have his fun torturing him. And it looks like Amanda won't be sitting home alone...Mike Greene has had a crush on her for a long time.

I LOVED this book. It held my interest from the first few pages, and I was riveted to the end. I identified with all the characters. I rooted for the tender-footed attorney, Amanda, and liked her transition over the years into a strong willed woman and capable attorney. I enjoyed the various other doctors implicated in the brutal crimes (I am not going into detail so I won't spoil the plot), and each one was a complete character that was well fleshed out. I even liked the various bit players, like Amada's father, or the policemen investigating the crimes, including Vasquez, because even they were complete characters easily identified and kept distinct from one another.

The plot was fantastic, and it kept me guessing until about  $\frac{3}{4}$  way through the book. Everything fit together wonderfully, and the obvious conclusions (given subsequent clues/facts) were spoken of/addressed by the characters, ALL of which were smart. They consequently made smart decisions, and then acted on those decisions, which kept me riveted to this book. There was no spot in the book where I didn't wholeheartedly agree with something a character did (i.e., no characters went into dark rooms where they heard a noise, no character didn't see a frame job for what it was, none went to meet suspicious characters unarmed, or without telling someone first, etc).

There was nothing I didn't like. My only irritation was this wasn't a series, because I wanted MORE as soon as I was done. But I'll have to settle for the author's next unrelated work.

I shouldn't try to write a review on my iPhone! I did write a few succinct lines which have disappeared into the iPhone ether! It is after 2:00 am down here so I will try to recover my comment later in the day!

My recovery attempt was unsuccessful, so here are a few not so succinct comments:

I listened to the audiobook, a relatively short 8:25 hours, which was well narrated by Anna Fields whose variety of vocal characterisations of the male voice are probably the best I have heard by a female narrator. The storyline required high a level of suspension of belief and even with multiple gruesome murders and a handful of pretty gruesome suspects, the identity of the really bad baddie was never in doubt - well that's what I thought anyway.

I found it difficult to stay engaged with this novel and there were quite a few "wtf" exclamations along the way. Normally I would breeze through an eight+ hours audiobook in a day or so, but I must admit I was tempted to fling this one onto the "DNF" shelf about two thirds of the way through. I thought that *Wild Justice* was the best book I've ever read. I enjoyed the suspense throughout the book. I also enjoyed all the surprises and twists in the book. I loved the ending of the book most.

Plot

Grant was selling a heart to Breach but the airfield they were at was raided, and Grant drove off with the money before Breach's henchman got the heart. Grant drove back to his partner's place to hideout. The surgeon let Grant in and gave him a drink. The surgeon asked about the deal, and Grant explained what happened. ### Characterization

Amanda is Frank's daughter and the lead counsel for Castle's case. She is also Tony's "girlfriend" toward the middle of the book and hostage at the end.

Frank is Amanda's father and lead counsel for Cardoni's case and the second layer for Castle's case.

Tony is the murder and Amanda's and Castle's "boyfriend." He is also a surgeon at St. Francis, Grant's partner, and the one who finds Cardoni.

Cardoni is a cokehead surgeon from St. Francis. Cardoni is also Castle's ex-husband and the suspected murder.

Castle is a surgeon at St. Francis and Cardoni's ex-wife. Castle was also Tony's "Girlfriend" during the investigation of Cardoni and his last victim.

Greene is a criminal investigator who works for the police. He looked into murders at the cabin, and what happened to Cardoni when he disappeared. He is also Amanda's date at the end.

Bobby is a cop who wanted to bring down Breach and took an anonymous call about Cardoni selling coke from Breach. He found the bodies at the cabin when he was looking for Cardoni. He becomes a private investigator after he's fired for going into the cabin illegally and becomes Castle's bodyguard.

### Setting

This book is set in modern-day Portland, Oregon. The setting is not particularly important other than its America. The time is only important because there has to be planes, organ transplants, and video technology.

Frank Jaffe's daughter, Amanda, gets her first taste of criminal defense while helping her dad on Cardoni's murder indictment. The good doctor disappears under bizarre circumstances and only to reappear several years later.

The slaughters resume as Cardoni resurfaces, but now the doctor's soon-to-be ex-wife, Justine Castle, is the primary person of interest, and with the help of former police officer, Bobby Vasquez, Amanda tries to save Dr. Castle from the death penalty.

Phillip Margolin's "Wild Justice" is a slice of murder intrigue, wrapped up in suspense, and warmed over with a excellent dialogue and descriptive scenes.

In Philip Margolin's Wild Justice, the first installment in the Amanda Jaffe legal thriller series, this thriller will give you chills and make you shudder. When Amanda Jaffe joined her father's law firm as an associate, he helped him take the case against Vincent Cardoni. A prominent doctor who's been arrested for series crimes, who had run into some trouble with the law and with the mafia. He claims he's innocent and that Justine Castle, his soon-to-be ex-wife had framed him. During his trial, they hit a snafu with Detective Vasquez's testimony who had a hard-on Castle and to nail him for the crimes. From there, they motioned to suppress the evidence against him. This is definitely the type of book that you can pick up and read without having to worry that you may not understand the technical legal jargon that's being tossed around. Margolin is able to relay this information in a way that makes it so anyone could understand it and I think that's the mark of a good author and storyteller.

The mystery is solid and intriguing. I guessed the killer's identity almost immediately. Due to prior experience with the genre and its conventions but I still really liked it. The plot was rock solid and Margolin was able incorporate some side plots to keep you interested and throw you off the trail.

The characters are likable. Amanda Jaffe is a strong female protagonist and I thought she was written well. Margolin actually has another strong female character besides Amanda whom I thought was also well written. The antagonist is decent, nothing special but not bad. My favorite character was Amanda's father, Frank. He was the well seasoned defense attorney who knows all the tricks of the trade but he was admirable and not slick or untrustworthy.

The Oregon setting is a welcome change from New York or the other major metropolitan areas that are so often used in these types of stories. Margolin painted a vivid picture of the Pacific Northwest and did a good job at describing its many features throughout the novel.

The ending was very satisfying, a bit different than what I've seen before.

This was damn good and I'm definitely going to check out some more of Margolin's work in the future.

How can you combine doctors, lawyers, local mafia, serial killers, abusive spouses, and harvested organs on the black market, into a psychological thriller set in the beautiful pacific northwest, and not succeed? I'll tell you how! Read Wild Justice.

Phillip Margolin lazily wrote Wild Justice, both in character development and from a plot standpoint. For example, we learn on page 160 that local mafia hitman Ed Gordon is an ex-marine who had been dishonorably discharged for assaulting an officer. An entire page later, in a chase scene in the woods, Margolin writes: "Gordon had hiked and camped in the army..." This sloppiness disproportionately bothered me and I wonder how it gets by both the author and the editor that the marines and the army are not the same.

The protagonist is a young hotty who graduated at the top of her law school class, completed a prestigious clerkship, has now gone on to work for Daddy doing criminal defense work in the private sector, and is of course eminently single. Her unbelievable character, who has set her love life aside to succeed as a professional, immediately is smitten with an old friend from childhood who is tall, dark and handsome (and a doctor, God love it!). When the impending relationship is consummated, of course, the protagonist is all a quiver. It is perhaps the worst gratuitous sex scene in fiction, ever.

The plot revolves around a serial killer and there are only 3 possible suspects: the coked-out doctor, his ex-wife he abused and who has a trail of dead husbands from whom she has collected life insurance proceeds, and the tall, dark and handsome love interest (did I mention he's a doctor?!). You'll never guess which one it is. Or, more likely, you'll guess who it is within the first hundred pages.

Setting aside that we are not concerned with the characters and the psychology is not interesting, the narrative does not have a credible inner logic. In three of the primary professions in this book, law enforcement, law practice, and medicine, we see unethical and unbelievable conduct throughout.

I debated giving this book 2 stars because it was interesting. But then I thought that train wrecks are interesting too, but that doesn't make them good.

On the plus side, this is a fast read and if you are given the book, like I was, then it is free!
